

## **Addendum to 2024 Consolidated Annual Report**

Accelerate Resources (ASX:AX8) or ("Accelerate" or "the Company") provides the following addendum to the Consolidated Annual Report dated 30<sup>th</sup> September 2024.

1) The Company would like to include a summary of the governance arrangements and internal controls that AX8 has put in place with respect to its mineral resources estimates and the estimation process, on Page 8 of the Consolidated Annual Report (LR 5.21.5)

The Company complies with Listing Rule 5.21.5 by utilising a combination of internal and external verification processes for its Mineral Resource Estimates. Any activities that result in material impacts on Resource estimates are required to be reported to the Board who will make appropriate announcements consistent with other announcements requiring Board approval. The Company provides transparent reporting with quality control in sampling, drilling techniques and employs strict quality control procedures during sample collection and analysis, including blanks, standards and duplications.

These protocols are consistent with JORC standards and ASX Listing Rules. The Woodie Woodie North Project inferred resource estimate of 1.2 Mt at 19.1% Mn is based on the November 2023 Mineral Resource Estimate (JORC 2012) reported on 30th November 2023 as shown in Table 1 as per the Consolidated Annual Report. The Company annually reviews and publishes its mineral Resources at the end of each calendar year as per Clause 15 of the JORC Code 2012.

2) The Company would like to insert the following on Page 8, notes section under Table 1: Summary of Mineral Resources Estimate.

The Exploration Target has been prepared in accordance with the 2012 edition of the JORC Code and is based on the current geological understanding of the geometry of the mineralised manganese occurrences. This understanding has been developed through exploration drilling and detailed surface mapping completed to date by the Company.

3) The Company would like to replace the Competent Persons Statement as per page 13 of the Consolidated Annual Report to the following. These amendments included additional Competent Persons Statement disclosures required for Exploration Targets. (LR 5.24)

## **Competent Persons Statement**

The Company confirms that the form and context in which the Competent Persons' findings are presented have not materially changed.

The Exploration Target has been approved by Mr Clark, who is an independent consultant at ERM Ltd who was engaged by Accelerate Resources Ltd and is a Member of the Australian Institute of Mining and Metallurgy (AusIMM). Mr Clark has sufficient experience relevant to the style of mineralisation and type of deposit under consideration and to the activity which they are undertaking to qualify as a Competent Person as defined in the 2012 edition of the Australasian Code for the Reporting of Exploration Results, Mineral Resources and Ore Reserves (JORC Code). Mr Clark has provided his prior written consent to the form and context in which the Manganese Exploration Target Statement appears in this Annual Report.

Information in this release related to Exploration Results (Manganese) is based on information compiled by Dr Joseph Drake-Brockman. He is a qualified geologist and a Fellow of the Australian Institute of Mining and Metallurgy (AusIMM). Dr Drake-Brockman has sufficient experience, which is relevant to the style of mineralisation and type of deposit under consideration and to the activity being undertaken to qualify as a Competent Person as defined in the 2012 Edition of the 'Australasian Code for Reporting of Exploration Results, Mineral Resources, and Ore Reserves'. Dr Drake-Brockman was employed by Drake-Brockman Geoinfo Pty Ltd and was under contract to the Company to act as Exploration Manager. The Company has granted Dr Drake-Brockman performance-based share options. Dr Drake-Brockman consents to the inclusion in this release of the matters based on his information in the form and context in which it appears.
